The Secret Vault – Terms of Use

Last updated: 12 August 2026

1. Introduction and Acceptance

1.1. These Terms of Use (“Terms”) govern your access to and use of The Secret Vault website at <https://thesecretvault.gic.com.sg> (the “Website”), which is operated by GIC Private Limited (“we”, “us”, or “our”).

1.2. By accessing the Website or registering for The Secret Vault (the “Event”), you agree to be bound by these Terms. If you do not agree to these Terms, please do not access the Website or register for the Event.

1.3. We may update these Terms from time to time. The most current version will be posted on this Website with the date of the last update. Your continued use of the Website after any changes constitutes your acceptance of the updated Terms.

2. Event Registration

2.1. **Pre-registration.** You may register for the Event in advance through the Website by providing the required registration details and selecting a preferred date and time slot. Upon successful registration, you will receive a QR code via email, which serves as your entry pass. You will also receive a reminder email prior to your selected date.

2.2. **Walk-in registration.** If you have not pre-registered, you may register as a walk-in visitor through a separate registration link available at the Event venue or on the Website.. Timeslots for walk-in registrations will be subject to availability at the point of registration. Upon successful walk-in registration, you will receive a QR code (displayed on screen or sent via email), which serves as your entry pass.

2.3. **QR code conditions.** Your QR code is personal to you and is valid for single use only. You must not share, transfer, reproduce, or allow any other person to use your QR code. We reserve the right to refuse entry to any person who presents a QR code that has already been scanned or that we reasonably believe has been duplicated or misused.

2.4. **Registration data.** By registering for the Event, you agree to provide accurate, current, and complete information as requested in the registration form. Registration fields may include your first name, last name, email address, age range, preferred date and time slot (for pre-registration), accessibility requirements, and consent to the collection and use of your personal data under the Personal Data Protection Act 2012 (“PDPA”).

3. Event Participation

3.1. **Conditions of entry.** Entry to the Event is subject to presentation of a valid QR code and verification by Event staff. We reserve the right to refuse entry to, or remove from the Event venue, any person who:

(a) does not hold a valid QR code;

(b) behaves in a manner that is disruptive, offensive, threatening, or dangerous to other attendees, staff, or property;

(c) fails to comply with venue rules, safety instructions, or directions from Event staff or security personnel; or

(d) breaches any of these Terms.

3.2. Assumption of risk. Attendance at the Event is at your own risk. While we take reasonable steps to ensure the safety of all attendees, we are not responsible for any personal injury, illness, loss of or damage to personal belongings, or any other loss or damage arising from your attendance at the Event, except to the extent mandated under applicable law.

3.3. Event changes and cancellation. We reserve the right to change the Event program, schedule, venue, or other arrangements, or to cancel or postpone the Event, at any time and for any reason, including due to circumstances beyond our reasonable control (such as severe weather, public health emergencies, government orders, or force majeure events). In the event of cancellation, we will use reasonable efforts to notify registered attendees via the email address provided at registration. We shall not be liable for any costs, expenses, or losses incurred by you as a result of any such changes, cancellation, or postponement.

3.4. Compliance with laws and venue rules. You must comply with all applicable laws of Singapore, venue rules, and any directions given by Event staff or security personnel while at the Event venue.

4. Personal Data Protection and Privacy

4.1. We are committed to protecting your personal data in accordance with the Singapore Personal Data Protection Act 2012 (PDPA). By registering for or otherwise attending the Event, you consent to us collecting, using, disclosing, storing and/or processing your personal data in accordance with these Terms and **GIC's Personal Data Protection Policy**, available at <https://www.gic.com.sg/privacy-statement/>.

5. Intellectual Property

5.1. All content on the Website, including but not limited to text, graphics, logos, images, trademarks, service marks, and design elements relating to the Event, is owned by or licensed to GIC Private Limited and is protected by applicable intellectual property laws.

5.2. You may not reproduce, modify, distribute, display, transmit, or otherwise use any content from the Website without our prior written consent, except for the limited purpose of viewing the Website and registering for the Event.

6. Limitation of Liability

6.1. To the fullest extent permitted by applicable law, we shall not be liable for any indirect, incidental, special, consequential, or punitive damages, or any loss of profits, revenue, data, or goodwill, arising out of or in connection with your use of the Website, your registration for the Event, or your attendance at the Event.

6.2. Our total aggregate liability to you for any claim arising out of or in connection with these Terms, the Website, or the Event shall not exceed the amount, if any, paid by you for Event registration.

6.3. Nothing in these Terms excludes or limits our liability for death or personal injury caused by our negligence, fraud, or any other liability that cannot be excluded or limited under the laws of Singapore.

7. General

7.1. **Severability.** If any provision of these Terms is found to be invalid or unenforceable by a court of competent jurisdiction, the remaining provisions shall continue in full force and effect.

7.2. **Waiver.** Our failure to enforce any provision of these Terms shall not constitute a waiver of that provision or our right to enforce it at a later time.

7.3. Entire agreement. These Terms, together with our Event Privacy Notice, constitute the entire agreement between you and us in relation to your use of the Website and registration for the Event, and supersede all prior or contemporaneous communications, whether written or oral.

7.4. Governing law and jurisdiction. These Terms are governed by and construed in accordance with the laws of the Republic of Singapore. Any dispute arising out of or in connection with these Terms shall be subject to the exclusive jurisdiction of the courts of Singapore.
